**Update on Tuition and Fees**

Ms. McMurphy reported that there are presently two separate student ID fees and the proposal is to consolidate the ID fees into one fee keeping the overall cost to the student the same. Student housing and meal plans rates are proposed to remain the same for fiscal year 2022 but will likely increase the following year.
