APPROVAL OF MINUTES

Ms. Wilkinson presented minutes from September 3^{rd} and October 1^{st} . Mr. Martin moved to accept the minutes as presented. Mrs. Wu seconded. Motion passed.

REPORTS FROM OFFICERS

Mr. Shoulders discussed a recent meeting between officers and Dr. Dinger and Dr. Duren. First off, they discussed student athlete absences. This topic of discussion was also presented in President's Cabinet and there are already steps being taken by the Athletic Director to address this issue. Mr. Shoulders also discussed the presentation of the faculty pay study to administration in this meeting. He will follow up with the status of the study. In addition, the faculty staff grievance policy was discussed and the suggestion to work with HR to make sure that faculty understood this process. Next, the Handbook Committee was discussed and the need to re-invigorate that committee. Laura Franks volunteered to be Committee Chair and get the committee back on track. Next, campus communications were discussed regarding the lack of technology on campus and the process to go through to request marketing. Next, health insurance was discussed to become familiar with the upcoming changes.

NEW BUSINESS

Extra-Curricular Absences

Mr. Martin discussed continued occurrences with student athletes missing classes for unofficial events. There is a need to understand what an "excused" absence is and the fact that academics seem to take a backseat to athletic events. Dr. Collins brought up that student athletes are refusing to take courses because coaches have instructed them that practice time is during that time. There were questions about practice times and how they have historically been after a certain time that shouldn't conflict but that has changed.

Freight Delivery

Mr. Martin discussed the changes in freight delivery and the fact that we are responsible in picking up all deliveries. This was addressed because there seems to be a shift in the dynamics of faculty responsibilities that pull them away from their teaching role.

Vaccine Mandate

There was some discussion about the recent vaccine mandates that have came down from the federal government. Mrs. Steele discussed the impacts on our students and employees

on the very recent mandate requiring vaccinations of employees by January 4th with few exceptions. There was much concern about how this will affect our campus. Mr. Shoulders will do a little more research into this.

President Vacancy

A question was posed as to the process for filling the presidency. Mr. Shoulders presented the information that the regents have not stated at this time who the interim will be but they will notify us when they start the process of moving forward in this regard. Besides that, there is a little known at this time.

OLD BUSINESS

Fundraiser

There was some discussion about a fundraiser and revisiting this when the results of the Faculty Pay Study are closer examined and a response to the resolution is received.
