### **New Business**

<u>Vice President for Outreach proposal</u> – The following memo will be sent to the President. **Faculty Senate response to the creation of VP for Outreach** 

Motion: Faculty Senate supports the efforts of the President to create this new position. (Lark, Ellzey). Motion unanimously carried.

Suggestions from faculty senate:

- 1. Why is this position limited to a Dean? Will it be a permanent part of the job description? We believe that it is a valid current requirement in light of the present budget situation.
- 2. Will there be extra pay? If so, how do we justify funding in light of current budget constraints (Carolyn McCargish)?
- 3. Some of these duties were under the VP of Student Services in the past. When Mr. Hibler left, was his salary split among the people who assumed his job duties? If so, will it come back to fund this position?
- 4. Why is summer school included in these duties? What other duties, if any, will the VPAA be assuming since this new position will be responsible for at least three of his current tasks?
- 5. Will the Dean have time to continue to do his/her own job?
- 6. This is not a common title. Will he/she have peers in other institutions?
- 7. Will Nursing's online classes come under this new VP or will they still be reporting to the Dean of Math, Science and Nursing?
- 8. Telecommunications Committee has tried to establish general education ITV classes but no faculty at OPSU seem interested. Will this fall to the new VP for Outreach?
- 9. Will Laura Dahl (PR) be under this new position?
- 10. We would like to see the bookstore under this VP for Outreach. The bookstore is currently not serving the students or the faculty. We believe that a Dean would make sure that the bookstore served students and faculty.

11. Will we ever do a search for VP of Student Services splitting that job and the job of the Registrar?

Thank you for the chance to respond.

<u>University College</u> – Faculty in the University College want representation on Faculty Senate. Are they a separate school? Until several questions have been answered, the University College will be invited to send a faculty member as a guest to Faculty Senate meetings. Dr. Goldsmith and Dr. Bryant will be asked for immediate clarification on this issue.

<u>Strategic Plan</u> – The strategic plan for OPSU was distributed among the senate members and placed on the agenda for the next meeting.
